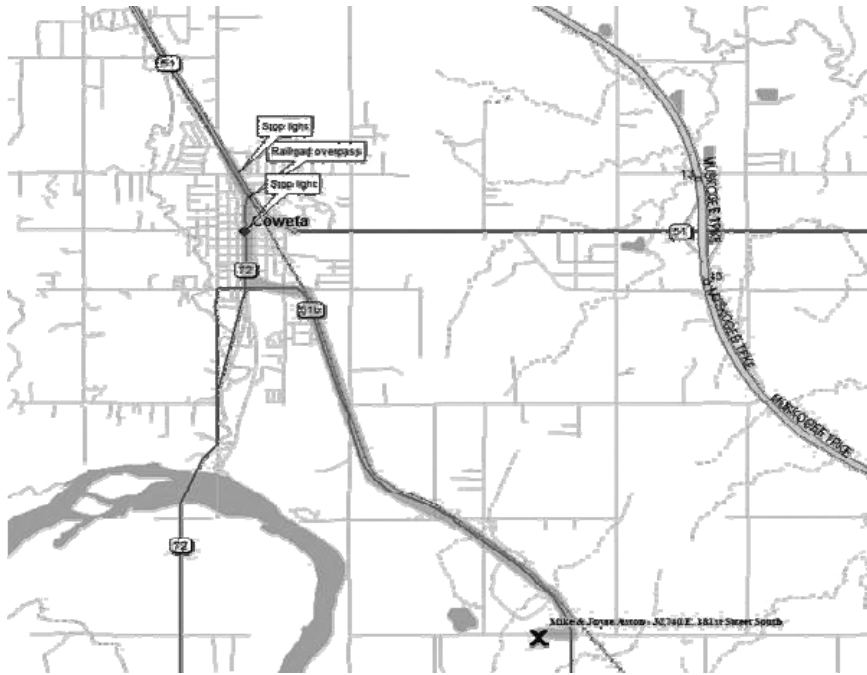


DIRECTIONS TO TRIAL LOCATION



From Tulsa:

Take the Broken Arrow Expressway to the 81st Street (Hwy 51) Exit; stay on Hwy 51 to Coweta; go under RR overpass and thru Coweta (approx. 7 short blocks) to Hwy 51B; turn left (East) on Hwy 51B; go 4 miles to E. 181st Street; turn right (West) on E. 181st Street; go 1/3rd mile to house on the left (South); name is on the mailbox.

From Wagoner or Muskogee Turnpike:

Take Hwy 51 West to Coweta RR overpass; Turn left under RR overpass and thru Coweta (approx. 7 short blocks) to Hwy 51B; turn left (East) on Hwy 51B; go 4 miles to E. 181st Street; turn right (West) on E. 181st Street; go 1/3rd mile to house on the left (South); name is on the mailbox.

From Muskogee:

Take Hwy 69 north to Hwy 51B; turn left (West) on Hwy 51B; continue on Hwy 51B thru Porter to the Hwy 104 Jct.; turn right (North) on Hwy 51B; go 2 miles to E. 181st Street; turn left (West) on E. 181st Street; go 1/3rd mile to house on the left (South); name is on the mailbox.

From Haskell:

Take Hwy 104 to the 51B Jct.; Take Hwy 51B (North) straight ahead 2 miles to E. 181st Street; turn left (West) on E. 181st Street; go 1/3rd mile to house on the left (South); name is on the mailbox.

ADDITIONAL NOTICES TO EXHIBITORS

ABSOLUTELY NO PUPPIES UNDER 6 MONTHS OF AGE ALLOW IN THE PROPERTY.

ALL DOGS PRESENT MUST BE HELD ON LEASH OR OTHERWISE RESTRICTED EXCEPT WHEN WORKING STOCK. Under NO circumstance will dogs be allowed to disturb the resting stock or interfere outside the arena with another dog's performance in the arena. Any dogs aggressive to persons or stock will be removed.

NO ALCOHOLIC BEVERAGES ALLOWED. Please bring your own chairs, shade, etc. Water and soda will be available for sale.

OWNERS OR THEIR AGENTS are solely responsible for the presence of their dog(s) and at test/trial arena. Judges are not required to wait for dogs.

RETURNED CHECKS do not constitute a valid entry fee

ENTRIES FEES SHALL NOT BE REFUNDED in the event that a dog is absent (unless replaced by an Alternate), disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Test/Trial Committee. If because of riots, civil disturbances, fire, act of God, public emergency or other acts beyond the control of the Club it is impossible to open or to complete the test/trial, no refund of entry fee will be made.

BITCHES IN SEASON shall be eligible and will run at the end of the class in tests and in catalog order as listed in the class in trials. Notify the Trial Secretary if your bitch is in season.
